
How to Use the Meat Establishment Directory

The 2005-2006 Wisconsin Meat Establishment Directory is designed to enable the user to locate and identify the business office and establishment location of every state licensed meat establishment in Wisconsin.

In the first section, each establishment is listed by county and is identified by meat establishment number, trade name, establishment address, telephone number, and mailing address of the home office and operation codes.

The second section is a numerical listing and the third section is an alphabetical listing of the meat establishments. This is useful when tracing the origin of a meat establishment and/or product.

There are 297 official meat establishments and 58 custom exempt meat establishments operating in the State of Wisconsin
